Nomination Guidelines: One award will be presented annually at the awards ceremony held in conjunction with the PALA Annual Fall Conference. LPNs/RNs that are currently employed in Personal Care and Assisted Living communities and are PALA members in good standing are eligible to receive the award. This award is for a Nurse that serves in a specific community and not a regional capacity.

All nominations must be submitted on this form along with a current resume of the nominee or a listing of the nominee's employment history and licenses/certifications held. Two reference letters are required and may be from staff, residents, family members of residents, or other individuals who can support this nomination. Supporting documentation should provide evidence of the nominee's dedication to the following:

- Communicates effectively with residents, family members and health care providers.
- Contributes to the quality of life and person-centered care for the residents.
- Demonstrates clinical expertise as a licensed nurse.
- Serves as a mentor to direct care staff.
- Provides a secure and safe environment for each resident, staff member, and community guest.
- Brings a positive attitude of cooperation to work each day.
